Effective January 1, 2021

We take seriously our responsibility to provide safe, reliable energy at reasonable rates. We work hard to control our costs.

In 2020, MGE worked with intervening parties to file a rate settlement agreement to resolve all issues in MGE's rate case. The Public Service Commission of Wisconsin (PSCW) reviewed and approved the settlement agreement, setting our electric and gas rates.

Electric rates will remain unchanged in 2021. Electric costs for 2021 include costs associated with two new solar projects: Badger Hollow I and Two Creeks. To achieve a 0% increase for electric rates, the deferred account balance credit from MGE's 2019 fuel cost plan reconciliation was incorporated into the settlement agreement.

The approved natural gas distribution and gas supply service rates reflect an overall increase of about 3.98% across all customers in 2021. The primary reason for the gas increase is technology improvements and infrastructure costs to maintain a safe and dependable system.

Base energy charge applies to all kWh used during all time periods.

Added on-peak charges apply Monday through Friday, excluding holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving and Christmas.

- **On-Peak 1** (10 a.m. to 1 p.m.)

- **On-Peak 2** (1 p.m. to 6 p.m.)

- **On-Peak 3** (6 p.m. to 9 p.m.)

***Customer maximum demand (kW)** is the highest 15-minute level in the current or preceding 11 billing periods.

****Distribution charge per kWh** Through the Distribution charge, MGE recoups the costs to build and maintain our electric distribution grid.

*****Monthly on-peak demand (kW)** is the highest 15-minute level reached during any on-peak period of the current billing cycle.
